

This summary of our literature review on the advisors of policy makers focuses on the key lessons for professionals and researchers who wish to share public health knowledge to inform public policy development.

When attempting to ensure that scientific knowledge is taken into account during the development of a public policy, one's first instinct is to try to share this knowledge directly with policy makers. But this would mean overlooking actors who play a central role in political circles: policy advisors. To improve understanding of their role, this document describes the profile of such advisors, the work they do, particularly as it relates to scientific knowledge, and their influence both on how knowledge circulates in the political sphere and on public policy development. This document is based on a literature review on knowledge sharing targeting public policies.
